The school should apply for further Extension of Provisional Affiliation before 30th June of the preceding year before the expiry of the date of Affiliation 'On Line' through CBSE Website <u>www.cbseaff.nic.in</u> or <u>www.cbse.nic.in</u> and send a copy of its confirmation page with prescribed fee of Rs 12,500/- in the shape of Bank Draft drawn in favour of Secretary, CBSE, Delhi.
- 21. Renewal of Registration of Society be ensured.
- 22. The school is eligible to open CBSE pattern class IX w.e.f. 01.04.2006 only. Accordingly 1st Batch of class X of the school will be appearing at the CBSE Examination to be held in the year 2008.
